Building inspectors, code enforcement officers, fire chiefs, health inspectors, and various other municipal officials are responsible for the enforcement of a variety of codes, regulations, and ordinances related to the use of land. These include both local regulations, such as zoning ordinances, site plan and subdivision regulations, health regulations, and the conditions of approval that accompany many land use board approvals, as well as state law, such as the State Building and Fire Code and statutes governing junkyards. Effectively enforcing these various codes and regulations can pose a challenge to municipalities.

DOJ's Final Rule on ADA Website Accessibility for Local Governments

In April, the Department of Justice's Civil Rights Division (DOJ) issued a final rule revising Title II of the Americans with Disabilities Act (ADA). The rule requires state and local governments to make their websites and mobile applications accessible for people with disabilities. The agency is adopting the technical standards of **Web Content Accessibility Guidelines (WCAG) 2.1 Level AA**, which requires 50 success criteria to make websites accessible. This includes converting pictures and documents so they can be read with assistive technology for individuals with vision loss and providing captions for live and prerecorded videos for individuals with hearing loss. In their fact sheet, DOJ has also listed **exceptions to this rule**, including archived content that is not currently used, pre-existing conventional electronic documents, content posted by third parties under certain circumstances, individualized documents that are password-protected; and pre-existing social media posts.

The Regulatory Flexibility Act covers small governmental jurisdictions with a population fewer than 50,000. This includes cities, counties, towns, school districts and special districts. On October 17, 2023, Advocacy submitted a comment letter to DOJ and commented that the agency underestimated the compliance costs and burden hours of this rule for small government jurisdictions. Small governments seek to provide accessibility for their constituents but have limited revenues and a lack of internal technical staff to meet this high technical standard. Advocacy recommended that DOJ

adopt regulatory alternatives to develop final regulations that offer flexibility to small governments while improving website accessibility to the public.

Fraud Alert for Vacant Land - Attention Tax Collectors and Tax Assessors

The conveyancing industry has seen several attempts (some successful) to fraudulently sell vacant land. Essentially, a fraudster presents themselves as the owner with forged identification, lists the property for sale with a realtor, and hopes they aren't caught prior to the closing where they abscond with the buyers money. A protocol has been adopted by conveyancing attorneys and title companies to mail a letter to the property owner at the address listed in the town taxing records alerting them to the pending transaction and requesting they contact them if the property is not actually for sale. This simple method has thwarted several attempted fraudulent transactions.

As more fraud attempts are caught, the fraudsters may turn their attention to your town records and request mailing addresses changed so the actual property owner won't be alerted. The conveyancing industry is asking you to be vigilant and review any request to change addresses for vacant land or unoccupied housing as attempted fraud, especially requests to change to a PO Box. A protocol could be enacted to mail a letter to the original address to confirm the actual property owner requested the address change. These simple letters have proven to be the best defense against the fraudsters.

EPA Finalizes First-Ever National Drinking Water Standard from PFAS Pollution

In summary, the new regulation sets an enforceable Maximum Contaminant Level at 4 parts per trillion for PFOA and PFOS, the two most studied of the PFAS chemical class. The new regulation also sets an enforceable Maximum Contaminant Level at 10 parts per trillion for 4 other PFAS chemicals and creates an enforceable Hazard Index for 4 additional PFAS chemicals when they are found together in mixtures.

This final rule will be effective 60 days after publication in the Federal Register, which is expected in the coming weeks. Water systems have three years to complete the initial monitoring that is required (by 2027). The new regulation also requires local governments and water utilities to inform the public of the measured levels of PFAS in their drinking water beginning in 2027. Water systems have five years to implement solutions to reduce PFAS in their drinking water if they exceed the levels (by 2029). EPA estimates that approximately 4,000-7,000 (of the 66,000) public drinking water systems will have to take action to reduce PFAS to meet these new standards.

EPA has a number of resources on its <u>website</u> include fact sheets, a Q&A doc, a tool kit on communicating and educating the public, and a guide on which at-home filters can help reduce PFAS in drinking water.

Additionally, EPA is holding three informational webinars for communities, water systems, and other drinking water professionals about the final regulation. The webinars will be similar, with each intended for specific audiences. Registration is required to attend and EPA requests that registrants only register for one of the webinars. Combatting PFAS Pollution - Tools for Local Government

The White House recently announced new findings and actions that will help to protect Americans' drinking water from contamination, including from "forever chemicals" like per- and polyfluoroalkyl substances (PFAS). PFAS are a set of human-made chemicals that can cause cancer and other severe health problems, pose a serious threat across rural, suburban, and urban areas, and that disproportionately affect disadvantaged communities. PFAS are considered "forever chemicals" because they are environmentally persistent, bioaccumulative, and remain in human bodies for a long time.

EPA is making available \$1 billion in grant funding through the Bipartisan Infrastructure Law (BIL) to help communities that are on the frontlines of PFAS contamination, the first of \$5 billion through the Law that can be used to reduce PFAS in drinking water in communities facing disproportionate impacts. These funds can be used in small or disadvantaged communities to address emerging contaminants like PFAS in drinking water through actions such as technical assistance, water quality testing, contractor training, and installation of centralized treatment technologies and systems.

NH Department of Environmental Services has DERA Funding Available NOW!

NHDES has been awarded new Diesel Emissions Reduction Act (DERA) funding from the U.S. Environmental Protection Agency for our NH Clean Diesel Grant Program. A competitive Request for Proposals (RFP) was released April 12, 2024!

Please review **the current RFP** for program details before submitting your proposal. **The proposal deadline is May 24, 2024 at 4 PM ET**.

Projects eligible for funding include diesel vehicle and equipment replacement, diesel engine replacement, etc. Common projects include plow truck, drayage truck, fire truck, wheeled loader, and school bus replacements. Existing units must be diesels, engine model year 2009 or older (unless replacing with electric) and must be scrapped. The replacement unit can be diesel, propane, natural gas, or electric and must be the same class and perform the same function as the existing unit. Grant funding reimburses a portion of eligible project costs; the portion depends on the project type. This is a competitive selection, based on specified Scoring Criteria and it is a reimbursement program.

NHRS Announces Reinstitution of Late Employer Reporting Penalties

As part of the transition to the new employer Data Reporting System (DRS), the automated penalties for late posting of monthly wage and contribution data have been turned off since late 2023. At this time, NHRS plans to re-institute late reporting and payment penalties beginning with the reporting of May member data due June 15.

The integrity of the data that NHRS receives from employers is crucial to its ability to effectively administer retirement benefits. Without timely and accurate payroll information and payment of contributions, the retirement system cannot post member interest, issue refunds to terminated members, or correctly calculate or finalize pensions for recent retirees.

For those employers that are up to date with their reporting, we thank you and appreciate your diligence in ensuring you are reporting and submitting payments on time.

For those employers that are behind, this advance notice is an opportunity to get your reporting and payments current to avoid these penalties. Any reports or payments for any prior periods that are made after June 15th will have penalties assessed.

Final OMB Uniform Grants Guidance Released

Last week, the White House announced the final <u>Office of Management and Budget</u> (<u>OMB</u>) <u>Uniform Grants Guidance</u>. This guidance is designed to create a streamlined set of rules and regulations for federal grants that ensure that Congress, agencies, and applicants have standard language and processes for grant awards and administration. Last week's announcement brings a big win for cities, towns and villages that receive federal grants in terms of how they can use federal funds.

Check Out NHDOE's Municipal Solar Grant Program

NHDOE's application for EECBG Program funding remains under review with USDOE.

The following are some program highlights to give municipalities a sense of program expectations:

- Municipalities must wholly own the project buildings & site location.
- Proposed projects must have at least 80% insolation.
- The Municipal Solar Grant Program will not cover costs unrelated to the direct material, equipment, or labor costs related to the design, construction, and installation of the solar system.
- Municipalities seeking to expand existing solar facilities or have projects that are full funded through other means are not eligible.


