# **Start Your Engines**

Legislative hearings begin next week, and in addition to the bills mentioned in the articles below, there are hearings on dozens of bills of municipal interest in the first week — with over 30 on Tuesday alone. The next several weeks will be intense. Please check the calendar in this *Bulletin* for a list of all hearings on municipal bills.

The House and Senate convened this week to officially begin the 2014 session. Both chambers have a number of "retained" (House) and "rereferred" (Senate) bills left from last session, all of which have been reported out of committee and are awaiting action by the full House or Senate. The House made a small dent in its retained bills, and will be meeting every Wednesday until it disposes of all of them. The Senate presumably will deal with re-referred bills over the next few weeks.

# Appointment of Town Clerks

One of the first bills scheduled for a hearing this year is **HB 1266**, an **NHMA policy bill** that would allow towns to vote to authorize the appointment of the town clerk by the selectmen or town manager. Current law, of course, requires the town clerk to be elected. The hearing is scheduled for next **Tuesday**, **January 14**, at **11:00 a.m.**, in **LOB Room 301**, before the Municipal and County Government Committee.

Although NHMA did not initiate this bill, allowing the option to appoint town clerks has been one of our policies for many years. It is important to understand that this bill does not require a town to have an appointed clerk; it merely lets the voters choose to exercise that option. If the voters can be trusted to elect a town clerk, it seems that they should be trusted to decide to give appointment authority to the selectmen or town manager.

There are numerous problems with the requirement that a town clerk be elected. Because an elected official must reside in the town, this requirement immediately restricts the field of candidates. In a small town, there

may not be a qualified candidate, or even an interested candidate. Further, as with any elected position, there is the danger that popularity or name recognition may trump competence. And the daunting prospect of running for re-election every three years, or even every year, may discourage an otherwise qualified candidate from considering the position in the first place.

We know there are a number of clerks who oppose the appointment option. While we work closely with the Clerks' Association on many bills (see article on **HB 183** below) and certainly respect their opinions, we believe it is time for towns to have the same option with respect to clerks that they have with respect to almost all other officials.

If your town has experienced problems because of the election requirement, please contact the Government Affairs staff to let us know your concerns; and please consider coming to the hearing on Tuesday.

# Retirement Tweaking

Although there is no comprehensive retirement reform bill in the legislature this year, there are a number of bills that make minor changes. On **Tuesday, January 14, in LOB Room 306**, the House Executive Departments and Administration Committee will hear the first of these bills. **HB 1148**, scheduled for a hearing at **10:00 a.m.**, would delay the reduction in pension benefits that currently occurs when a New Hampshire Retirement System (NHRS) retiree reaches age 65. The bill changes the point of reduction from age 65 to the time when the retiree reaches full retirement age for Social Security purposes, which may be greater than age 65. The NHRS states in the fiscal note that this will result in increased pension benefits for some retirees, which will in turn result in *increased employer contribution rates*, estimating the increased cost to the state and local government (municipal, school district and county) employers at over \$12 million for fiscal years 2016 through 2018. **NHMA policy** is to *oppose* any expansion of pension benefits that increases municipal employer costs.

The second bill, **HB 1494**, scheduled for a hearing at **11:00 a.m.**, deals with a variety of NHRS administrative issues, several of which appear to be clarifications of existing law or practice. However, the bill also expands interest charges and imposes a new penalty on employers for non-compliance with NHRS data reporting requirements or for incorrect data reporting.

Current law allows the NHRS to assess interest at one percent per month for retirement contributions (employer and/or employee) not remitted on time. **HB 1494** expands the assessment of interest to situations when the contribution payment cannot be processed by NHRS "due to data reporting errors." Additionally, a new penalty of \$25 per day would be imposed for non-compliance with data reporting requirements, including data not remitted on time or data that cannot be processed

due to reporting errors. This daily penalty appears to be driven in part by the new reporting requirement enacted last year that requires employers to report monthly information about NHRS retirees working in part-time positions. Since there is no payment associated with this new report, the one percent interest charge could not be used as an enforcement mechanism, hence the creation of a daily penalty instead. The daily penalty includes a provision authorizing the Board of Trustees to abate all or part of the charge if it is shown that the employer "did not willfully, intentionally, through gross negligence, or through a pattern of negligence fail to file that data as required."

# \$\$\$ Timber Tax Repeal \$\$\$

**HB 1441** would repeal RSA 79 in its entirety, thereby eliminating all income from the timber yield tax, reducing municipal revenue by approximately \$2.6 million per year. The bill also inserts a new exemption in RSA 72 so that all growing wood and timber (other than fruit trees, sugar orchards, Christmas trees and a few other specific varieties) would not then be subject to general property taxation either. **HB 1441** is scheduled for a hearing in the House Resources, Recreation and Development Committee on **Tuesday**, **January 14 at 1:45 p.m.** in **LOB Room 305**. Please let <u>committee members</u> know the impact of eliminating this important local revenue source in your municipality!

#### Veto Override Fails on Absentee Ballot Bill

An effort to override Governor Hassan's veto of **HB 183**, relative to processing absentee ballots, failed on Wednesday. The override motion garnered a 176-163 majority, but that was well short of the two-thirds margin required.

**HB 183,** which was strongly supported by NHMA, the City and Town Clerks' Association, and seemingly every moderator in the state, would have allowed moderators at state and local elections to begin processing absentee ballots two hours after the polls open, rather than waiting until 1:00 p.m., as current law requires.

Fortunately, the Senate Public and Municipal Affairs Committee has recommended an amendment to a re-referred Senate bill from last year — coincidentally, **Senate Bill 183** — that would accomplish what **HB 183** set out to do, and that apparently satisfies the last-minute objections that were raised by its opponents. It is unclear when **SB 183** will go to the full Senate, but presumably it will be within the next few weeks. If it passes the Senate, it will then need to go to the House. We will keep you posted.

# Paint Stewardship Program

HB 1570 would establish a "paint stewardship program," under which a nonprofit organization approved by the state would dispose of unused paint collected at specified locations throughout the state, which may include municipal transfer stations and retail stores. The program would be funded by a mandatory fee on all paint sold within the state, and all manufacturers of paint sold in the state would be required to participate in the program.

It appears that the program would significantly reduce the amount of paint disposed of as trash at municipal solid waste facilities and "hazardous waste days," thus saving money for municipalities. We have heard from a few local officials who favor the bill, but it would be helpful to get more opinions. Please take a look at the bill and let us know what you think. A hearing on the bill is scheduled before the Environment and Agriculture Committee on **Tuesday**, **January 14**, at 1:00 p.m., in **LOB Room 303**, so it would be helpful to receive comments before then — and, of course, you can attend the hearing.

# NHMA Files Brief in Case Challenging Retirement System Changes

NHMA, together with the New Hampshire Association of Counties and the New Hampshire School Boards Association, filed an *amicus* brief in the New Hampshire Supreme Court this week in the case of *Professional Fire Fighters of New Hampshire v. State.* The plaintiffs in that case are challenging the 2011 legislative changes that require increased contribution levels by state and local employees who are members of the New Hampshire Retirement System. They claim that the Retirement System statute is in fact a contract with employees, and as such cannot be modified to increase employee obligations or reduce their benefits.

NHMA, in support of the state's position, argued that (1) the Retirement System statute is not a contract, but a statute that can be amended at the will of the legislature, like any other statute; and (2) if the statute can somehow be construed as a contract, it has been breached many times in recent years to the detriment of political subdivisions — so the state should get ready for a torrent of lawsuits by political subdivisions. <u>HB 1605-FN</u> requires the secretary of state to perform random audit recounts of towns and wards that use optical scan equipment to count votes representing 5 percent of the votes cast after each general election. Rep. Till of Derry; **EL**.

<u>HB 1609-FN</u> recodifies RSA 617, relative to the forfeiture of personal property. Rep. Warden of Manchester; **JUD-H**.

<u>HB 1610-FN</u> defines the term "natural repose" to determine liability for the excavation tax. Rep Daniels of Milford; **M&CG**.

<u>HB 1620-FN</u> regulates the use of drones by government agencies and individuals. Rep. Kurk of Weare; **CJ&PS**.

<u>HB 1626-FN-A-LOCAL</u> provides for the licensing of up to six facilities for video lottery in the state. Rep. Vaillancourt of Manchester; **W&M-H.**

- <u>SB 300</u> allows municipalities to calculate and set their own property tax rates, subject to certain requirements. Sen. Sanborn of Bedford; **W&M-S**.
- SB 301 permits a town to prohibit for 2 years a petitioned warrant article for the purpose of adopting or rescinding an official ballot referendum form of government after such a question has failed to receive a 3/5 majority vote in 2 successive town meetings. Sen. Gilmour of Hollis; **PMA.**
- <u>SB 302</u> provides that criticism of an employer cannot be grounds for termination of employment. Sen. Pierce of Hanover; **COM-S.**
- SB 304-LOCAL requires county commissioners to value property subject to agreements in lieu of taxes every 2 years, requires county commissioners in Coos County to use the department of revenue's valuation of certain property subject to payments in lieu of taxes, and requires towns seeking to enter into agreements with utilities for payments in lieu of taxes to obtain an expert evaluation of the agreement before it is signed. Sen. Woodburn of Dalton; **W&M-S**.
- <u>SB 315-FN</u> establishes the board of building officials for the certification and regulation of persons enforcing the state building code and conducting building inspections, and prohibits any person from acting as a building official without being certified by the board. Sen. Carson of Londonderry; **ED&A-S**.
- <u>SB 333</u> clarifies the term manufactured housing for purposes of the assessment of property taxes and exempts property meeting the definition of recreational vehicle. Sen. Forrester of Meredith; **W&M-S.**
- <u>SB 339-FN</u> allows the department of administrative services to contract with a credit card issuer to establish a credit card affinity program in which the fees received by the state are dedicated to reducing the retirement system's unfunded liability. Sen. Stiles of Hampton; **F-S.**
- SB 344 removes limitations on a municipality's authority to enter into franchise agreements for cable service within the municipality. Sen. Odell of Lempster; **PMA. NHMA Policy.**
- <u>SB 347</u> allows pleas by mail for violations of municipal land use ordinances and establishes a fine for a landlord's failure to designate an agent for service of process. Sen. Watters of Dover; **PMA**.
