Crossover

Crossover, the unofficial halfway point of the legislative session, is next Thursday, March 27. That is the last day for the House to act on House bills and for the Senate to act on Senate bills. The House has many bills remaining, and thus will be in session Tuesday, Wednesday, and Thursday next week, with no committee hearings scheduled for the week. The Senate will be in session only on Thursday, but it could be a long day.

This is a good time to take stock of the many bills affecting municipalities, some of which we have not written about because of time or space constraints, and many of which will see final action next week. We will provide updates on as many of these as we can over the next few weeks.

The Government Affairs staff will present a webinar on the status of municipal bills on **Monday, March 31.** The webinar is open to local officials from municipalities that are members of NHMA, and there is no charge to participate. Road Toll Round Two

In last week's *Bulletin*, we reported that the Senate had passed **SB 367**, an **NHMA policy bill**, which will increase the road toll (gas tax) by approximately 4.2 cents per gallon effective July 1, 2014. The Senate had also referred the bill to the Finance Committee for further review. On Thursday of this week, that committee held a lengthy hearing and then approved an amendment to the bill to address concerns about how the additional revenue (\$33 million annually) will be spent.

By a 4-2 vote, the Finance Committee recommended the bill as Ought to Pass with Amendment. Here is a summary of how the money will be allocated, based on the amended version of the bill:

• 12 percent of the increase in the revenue will go towards highway block grant funding for municipalities for the fiscal year beginning July 1, 2015 and for subsequent years.. This is estimated to be approximately \$4 million per year above the current \$30 million block grant funding level.

- For fiscal year 2015, \$8.3 million will go toward additional state aid for municipal bridges. In subsequent years, that amount will be \$6.8 million, which will double the amount of municipal bridge aid currently provided.
- In fiscal year 2017, \$8.3 million will go toward paying the debt service due on \$200 million of bonds authorized by this bill for the completion of the Interstate 93 widening project south of Manchester, which is currently unfunded. In subsequent years, the debt payments will be approximately \$16.5 million.
- For fiscal years 2015, 2016, and 2017 an additional \$25.2 million, \$22.6 million and \$14.2 million respectively will go to highway and bridge betterment programs. The betterment programs fund construction, reconstruction, resurfacing and maintenance of that portion of the state highway system not supported with federal aid (i.e., state maintained local roads). In subsequent years, all money remaining after funding the previous three categories will go towards the betterment programs. This is estimated to be approximately \$5.5 million per year.

The amended bill establishes a committee to study the effectiveness and efficiency of the Department of Transportation with a report due by December 1, 2014, and repeals the 4.2 cent rate increase 20 years after the bonds are issued, or when the bonds are paid in full, whichever is earlier. Finally, the bill eliminates the tolls at exit 12 on the Everett turnpike.

While the state's highway infrastructure needs may still exceed the amount raised by a 4.2 cent increase in the road toll, this is a significant step by the Senate supporters of **SB 367** to address the deteriorating condition of New Hampshire's roads and bridges. *Please urge your senator to support the committee recommendation of Ought to Pass with Amendment on SB 367 when this bill is voted again next week by the full Senate.*

Right-to-Know Law Bill Delayed

There is good news and bad news on **HB 1591**, the bill described in <u>last week's Bulletin</u> that would require all public bodies (except the legislature!) to post notice and an agenda at least 72 hours before any meeting. The good news is that as of Thursday, there was a strong movement to table the bill. The bad news is that the House didn't get to the bill on Thursday (it disposed of only eight bills in eight hours), so **HB 1591** will go to the floor on Tuesday—we think. If the bill is tabled, and if it is not removed from the table before crossover, it will die on the table—but, as we have often stated, anything can happen.

There is no question why this bill has run into such strong opposition—it is because so many legislators have heard from their local officials about the havoc it

would cause. Your phone calls and e-mails to your representatives have made a huge difference. We have spoken to many representatives who have heard and understood the message that local governing bodies cannot wait three days (or more likely four days, as we explained) to take every action, and cannot freeze their agendas three (or four) days in advance.

We thank you all for your efforts in slowing this bill, but unfortunately it's not over. If you haven't yet talked to your representatives and explained why HB 1591 is a bad idea, please do so before Tuesday.

By the way, a few people have expressed confusion about the bill, saying that it appears to create a grievance commission, rather than having anything to do with public notice requirements. If you are confused, it is probably because you are looking at the bill as introduced. The committee amendment, which is what the House will be voting on, removed all of the original language from the bill and replaced it with language that changes the notice requirements. You can find the amendment by going to the bill's docket and clicking on "Amendment # 2014-0658h."

Submit Your Legislative Policy Proposals!

In April NHMA will begin its legislative policy process for the 2015-16 biennium. While the next legislative session may seem far away, now is the time to think of things about your municipal responsibilities that might work better with a legislative change.

Could you do your job better if a statute were changed? Have you received citizen complaints that you couldn't address because you needed legislative authority? Are there outdated provisions in the law that need to be modernized or streamlined? Please let us know.

NHMA's legislative policy committees guide its legislative policy development. The committees will hold their organizational meeting on Monday, April 7. The committees will review legislative policy proposals submitted by municipal officials and make policy recommendations for consideration at the NHMA Legislative Policy Conference on September 26.

If you have a policy suggestion, please send it in soon. Policy proposals may be submitted by a board or a local official from a member municipality.

A <u>policy proposal form</u> should accompany each proposed legislative policy. It should include a brief (one- or two-sentence) policy statement, a statement about the municipal interest served by the proposal, and an explanation that describes the nature of the problem or concern and discusses the proposed action that is being advocated to address the problem.
