What is Congressionally Directed Spending?



SENATOR FOR NEW HAMPSHIRE

Criteria

- Place-based
- Short-term \bigcirc
- Limited to 1% of discretionary spending, and must comply with the Rules of the Senate (Senate only)
- Applicable to a certain number of eligible accounts Ο
- Subject to audit and transparency measures Ο
- Using earmarks, Congress can make targeted investments in specific regions and direct funding for a multitude of uses:
 - Education improvement \bigcirc
 - **Distance learning** Ο
 - Rural broadband \bigcirc
 - Agricultural research \bigcirc
 - STEM research and \bigcirc education
 - Conservation \bigcirc
 - Health improvements Ο

- Water infrastructure and Ο watershed preservation
- Forest management Ο
- Law enforcement Ο technology
- Crime prevention Ο



**The table above shows a comparison of the House and Senate directed spending process Please note that while the Senate Appropriations Committees does not require evidence of community support, this is a requirement for applicants submitting their proposals to the Office of Senator Shaheen.

- While some elements of the reformed process are similar, the House and Senate differ on the number of eligible accounts for CDS requests.
- House members may only submit 15 community development project requests. Senate members do not have this limitation.

Byrne JAG Discretionary Projects

- The Program provides states, territories, tribes and local governments with critical funding necessary to support a range of program areas including:
 - law enforcement
 - prosecution and court
 - prevention and education
 - corrections and community corrections, including reentry
 - drug treatment and enforcement
 - planning, evaluation and technology improvement
 - crime victim and witness initiatives

- mental health programs and related law enforcement and corrections programs
- implementation of state crisis intervention court proceedings and related programs or initiatives (e.g. mental health courts, drug courts, veterans courts, etc.)

Byrne JAG Discretionary Projects

- > Examples:
 - Manchester PD: Senator Shaheen secured \$110,000 to fund expanded critical incident stress management training among law enforcement as well as training to build resiliency within the Department.
 - Nashua PD: Senator Shaheen secured \$110,000 to provide the public safety bomb technicians of the Hazardous Device Unit with bomb suits and helmets.
 - Town of Gorham: Senator Shaheen secured \$426,000 fund Town of Gorham's efforts to upgrade its current radio system to include a new Repeater at the summit of Pine Mountain and a 4-Site Simulcast Communication System to resolve ground-to-air coverage gap issues.

- The COPS Office awards grants to hire community policing professionals, develop and test innovative policing strategies, and provide training and technical assistance to community members, local government leaders, and all levels of law enforcement.

 - Preparing for Active Shooter Situations (PASS) Program
 - COPS Hiring Program (CHP)

Community Oriented Policing (COPS) Projects

- > Examples:
 - Newington Emergency Communications Infrastructure: Senator Shaheen secured \$170,000 to fund the Town of Newington's efforts to upgrade their emergency communications equipment.
 - Belknap County Sheriff's Office. Senator Shaheen secured \$600,000 for Belknap County to purchase a server system to host and maintain all local law enforcement records.

- · Agricultural Research Service, Building and Facilities (ARS B&F)
- · Animal and Plant Health Inspection Service (APHIS) (S&E)
- Watershed and Flood Prevention Operations (WFPO)
- Rural Development, Community Facilities grants
- Rural Development, Distance Learning, Telemedicine, and Broadband Program (DLT) grants

A recipient of CDS must apply for funding through the normal application process. The Agriculture Subcommittee will not fund CDS items if a recipient cannot meet all program requirements.

- > How do I know whether my project meets the eligibility requirements?
 - Information on CDS-eligible accounts can be found in the Shaheen CDS web portal. Please use the federal agency's website to review the program and grants awarded to determine whether your project is eligible for funding.



Frequently Asked Questions

> I submitted my CDS request. What happens now?

- The Shaheen staff will review the information you provided to determine whether your request(s) meets our internal and committee criteria for submission as a formal CDS request from Senator Shaheen.
- We will notify you of our determination and keep you informed as the appropriations process moves forward

My project was not selected. What do I do?

 While your project may not be eligible for CDS funding, there are a number of federal resources available to fund economic development and community development projects.
