

COMMUNITY POWER IN NH - Legal Considerations

Community Power can be simple: purchasing energy requirements for small group of customers within municipal boundaries; or **complex:** multiple municipalities joining together to offer energy, special rates and products to all customers that do not opt out.

COMMUNITY POWER BILL - SB 286 Expands municipal power aggregation to allow more breadth and flexibility.

How is a Community Power system formed?

Governing body of municipality or county forms a community power committee (could be existing energy committee).



The Community Power Committee develops a community power plan. The plan shall provide for:

- a. universal access
- b. reliability
- c. equitable treatment of all classes of customers subject to any differences arising from varying opportunities, tariffs, and arrangements between different electric distribution utilities in their respective franchise territories, and
- d. shall meet, at a minimum, the basic environmental and service standards established by the commission and other applicable agencies and laws concerning aggregated service

The Plan shall detail:

- a. The organizational structure of the program.
- b. Operation and funding.
- Rate setting and other costs to participants, including whether energy supply services are offered on an **opt-in basis** or on an **opt-out basis** as an alternative default service.
- d. The methods for entering and terminating agreements with other entities.
- e. The rights and responsibilities of program participants.

The Plan shall detail:

f. How net metered electricity exported to the distribution grid by program participants, including for group net metering, will be compensated and accounted for.

g. How the program will ensure participants who are enrolled in the Electric Assistance Program administered by the commission will receive their discount.

h. Termination of the program.

The Committee shall solicit public input in the planning process and shall hold public hearings. The Committee shall approve the final plan which the committee determines "is in the best, long-term interest of the municipality or county and the ratepayers."

The Plan must be approved by a majority of voters if it requires customers to opt out of aggregation. (Note that for customers that receive energy from a competitive supplier, they will always be opt in.)

Joint Operation of Community Power program - pursuant to RSA 53-A; Committee drafts interlocal agreement with other participants and then approved by governing board – may also need voter approval (e.g., appropriation, opt out). Agreement must be submitted for approval by the Attorney General. Then file with municipal clerks and the Secretary of State.

Interlocal agreement must contain:

a. duration, precise organization, composition and nature of any separate legal or administrative entity created by the agreement and the powers delegated to it

- b. the purpose of the agreement
- c. the manner of financing the joint or cooperative undertaking and establishment and maintenance of a budget
- d. how the agreement is terminated and the disposal of any property obtained under it, and
- e. any other necessary and proper matters.

JOINT OPERATION OF COMMUNITY POWER – How will it be operated? Create a separate legal entity – must follow rules for creation of a new entity. JOINT OPERATION OF COMMUNITY POWER – How will it be operated? If not creating a new legal entity, must make sure governing board has fair representation of all participating entities.

Contracting for Services - Community Power entity will likely need to enter into contract with third parties to provide some or all of the aggregation and other services provided to customers. Make sure following all local contracting requirements.

Funding Community Power – Create an enterprise fund; SB 286 allows for revenue bonds or loans from existing enterprise fund (so long as use is consistent with purpose of that enterprise fund). May also apply for grants and other similar programs. Eventually should be a self-sustaining operation based on rates charged to customers.

PUC OVERSIGHT? Community Power is not regulated by PUC. Services and rates only need to be approved by internal processes.

PUC has started pre-rule-making process. The PUC will regulate:

- a. Utility sharing customer information with Community Power
- b. Interaction on meters
- c. Transition on and off utility default service





What is CPNH?

Town, city, and county governments are working together to establish 'CPNH': a locally governed public power nonprofit to provide enabling services to participating Community Power Aggregations (CPAs)




Individual CPAs retain control over individual energy portfolios, rates, and other community-specific policies/programs

CPNH remains in the design phase and has yet to be established as a legal entity

Governance - Joint Action

CPNH organizing communities have begun drafting 'Governance Agreement' under RSA 53-A, Agreements Between Municipalities. CPNH will be a locally governed nonprofit accountable to member communities.




Vermont Public Power Supply Authority
